- Can my business sell only DC Lottery Products?
 Retailers must operate a lawful establishment in the
 District of Columbia in which the sale of lottery tickets is not its primary purpose or business.
- How long does it take to become a DC Lottery Retailer?
 It takes approximately four weeks to complete the licensing approval process.
- Does a DC Lottery Retailer receive training?
 Yes, training is scheduled on Tuesdays and Thursdays.
- If I no longer want to sell DC Lottery products what should I do?

You must notify the DC Lottery at least forty-five (45) days prior to closing.

- What should I do if I need to "temporarily" deactivate my DC Lottery equipment?
 You must notify the DC Lottery at least ten (10) days in advance.
- Is the DC Lottery License transferrable?
 DC Lottery licenses are nontransferable.
- Does my DC Lottery license expire?
 Retailers are required to complete and submit a renewal application every two (2) years.
- Do I have to comply with the Americans with Disabilities
 Act (ADA) to become a DC Lottery Retailer?
 The DC Lottery cannot advise Retailers with regard to
 accessibility requirements other than those required by
 the DC Lottery's Retailer Accessibility Program (RAP).
 Compliance with the RAP does not guarantee that a
 retail location complies with other accessibility
 standards required by federal or state law.
